

Values

Reviews

- Recognize the contexts within which submitters are operating
- Recognize the labor involved in reviewing
- Enable conversation across global scholarly contexts
- Reduce labor required to do double anonymous review

Process

- De-anonymized review process
- Adopted Oxford Abstracts
- Created transparent review criteria

Challenges

- Differing expectations across a global academic community
- Learning curve of a new system
- Aligning reviewer expertise with proposal content

Conferences are critical infrastructure that allow communities to create, facilitate, and curate knowledge. In organizing the Global DH Symposium, we embed social justice-oriented values, global engagement, and care work at every level while being conscious of our positionality in Western colonial institutions.

Each year, we reinvent the Symposium with those values in mind, looking for ways to better support digital humanities practitioners across the world. We navigate difficult conversations about how to enact these values while recognizing the labor involved in doing so.

Below, we reflect on three areas of values-driven reinvention that speak to the ways that we try to hold ourselves responsible to the community that we cultivated over the past nine years.

Modalities

Values

- Reach a broad global audience
- Presenters can share their work regardless of ability to travel
- Environmental sustainability
- Accessibility in terms of language and of disability


Process

- Special double issue with Reviews in DH
- Journal of Global Digital Humanities (Launching in 2025!)


